

New Delhi: Defence minister Rainath Singh on Thursday chaired the second meeting of BJP's 27-member manifes-

"Today the second meeting of the election manifesto committee was held at the central office of BJP. In this meeting, various topics and suggestions were discussed with a view to fulfilling the resolve of building a devel-

oped India under the leadership of PM Narendra Modi," Singh, who is the chairperson of the party's manifesto draft panel, posted on X.

Convener of the panel and finance minister Nirmala Sitharaman and her ministerial colleagues, Arjun Munda, Bhupendra Yadav, Ashwini Vaishnaw, Arjun Ram Meghwal, Kiren Rijiju along with senior party leaders Ravi Shankar Prasad, Vinod Tawde, Radha Mohan Agarwal and Manjinder Singh Sirsa attended the meeting. Gujarat CM Bhupendra Patel and UP deputy CM Keshav Prasad Maurya were also in attendance.

In line with the PM's assertion that his first two tenures were utilised to lay the foundation for a developed India and make it the third largest economy in the world, and the next tenure will be focused at attaining it, sources

said the party is likely to shed light in its election manifesto on the roadmap about its "Viksit Bharat" pledge by 2047 when the country will be celebrating 100 years of its independence.

A bench of Justices J K Maheshwari and Sanjay Karol held that 2017 order of District Caste Scrutiny Committee which validated Kaur's caste claim as 'Mochi' was right and the HC inadvertently undertook an erroneous exercise of appreciating evidence and swayed itself into a roving inquiry which was not expected as per settled legal position.

"When the scrutiny committee which is principally tasked with the fact finding exercise for validation of caste claim, had applied its mind and reached a conclusion, then in such a situation, whether a roving enquiry by HC was required? It is well settled that high courts as well as Supreme Court should refrain themselves from deeper probe into factual issues like an appellate body unless the inferences made by the concerned authority suffers from perversity on the face of it or are impermissible in the eyes of law. In the instant case, the order passed by the committee reflects due appreciation of evidence and application of mind and in absence of any allegation of bias/malice or lack of jurisdiction, disturbing the findings of the committee cannot be sustained,' the bench said.

Kaur was elected from reserved seat on the basis of the certificate which attested to her being a 'Mochi' which is Scheduled Caste in the state making her eligible to contest from a reserved seat. The court had in 2021 stayed the HC order, paving the way for her to continue to represent the constituency in Parliament.

"He will be the obvious choice for us to lead the campaign," the functionary added. Singh's release has come at a time when the beleaguered AAP is in the middle of its worst-ever crisis, trig-

gered by the arrest of party's national convener and Delhi CM Arvind Kejriwal just ahead of Lok Sabha elections. It is likely to give AAP a much-desired boost just before the polls and rejuvenate the party cadre.

Singh would be at the forefront in Delhi. Their itinerary for their travel to all states will be drawn in due course of time, the functionary said. Talking to reporters,

Singh said he would discharge whatever duty would be assigned to him in the Lok Sabha polls. "The party will prepare the future strategy. I am a party worker and follow the party's directions," the AAP leader added. Sources said Singh held a

long meeting with senior party functionaries on Thursday afternoon after his morning visit to Rajghat and to the residences of Kejriwal and former health minister Satyendar Jain. The party function aries deliberated upon the focus of the campaign and slogans that might be used to impress upon the voters. Singh is also likely to be involved in designing a joint campaign with Congress, which is contesting three seats in Delhi, sources said.

Delhi BJP president Virendra Sachdeva, however, said Sanjay Singh was released on bail but behaving as if he had been discharged of the charges of liquor "scam".



Ball in Tesla's court: India Xactivates 'Community Notes' on company's EV plans

he country's industry secretary said the ball is now in Tesla Inc.'s court to lay down its investment plans for the South Asian nation after the government cut import duty on electric vehicles

The industry department last month released a comprehensive policy for boosting EV manufacturing in the world's most-populous Following that move, it's up to Elon Musk's carmaker to "make the announcements of their manufacturing plans," Rajesh Kumar Singh, secretary of department for promotion of industry and internal trade, told *Bloomberg* in an interview on Thursday.

"We will help them out in terms of giving them the contacts at state level," Singh said. "There have been contacts made at that level with state governments and the central government. VinFast has already announced and we expect a few others.'

Vietnamese automaker VinFast recently broke ground on an EV manufacturing facility in India's southern state of Tamil Nadu.

Tesla is planning to send a team of people to scout for locations in India this month for a proposed \$2 billion to \$3 billion electric car plant, the Financial Times reported earlier this week, citing people familiar with the matter that it didn't identify. Tesla would also look to increase purchases of auto parts from the nation to as much as \$15 billion, Bloomberg reported in November. Musk's carmaker has for years been been making a case for cutting import taxes before it commits to any significant investment in one of the world's biggest automobile markets.

Tesla begins car production in Germany for export to India

Tesla has begun production of right-hand drive cars at its plant in Germany for export to India later this year, three people aware of the company's plans told Reuters, as it moves ahead with a possible entry into the world's thirdlargest car market

A team from Tesla is expected to visit India later this month to look at sites for a local car manufacturing plant that would require an investment of about \$2 billion, said two of the three people, who declined to be named because the plans are not public yet.

India last month slashed the import tax rate on certain electric vehicles if their makers invest at least \$500 million in the country and start production there within three years. The move is a win for Tesla, which had lobbied for months for lower taxes, but faced resistance from local carmakers.

YouTube okayed ads with misinformation on India's election process: Report

New Delhi, 4 April

Video streaming giant YouTube allegedly approved almost 50 advertisements having misinformation about elections recently, according to a joint investigative report by digital rights group AccessNow and Global Witness. But YouTube, while reacting to the report, said that none of the advertise ments ever ran on its systems.

The advocacy groups claimed that a total of 48 misleading advertisements in English, Hindi, and Telugu containing content prohibited by YouTube's advertising and elections misinformation policies, were allegedly approved by the streaming giant.

The advertisements were however pulled down after they were approved from YouTube, but before they could be published, the report confirmed.

"Heading into the crucial election year of, tech platforms made tall promises about safeguarding electoral integrity, but the proof is in the pudding: YouTube greenlit all 48 ads violating its policies, submitted as part of our investigation," said Namrata Maheshwari, Senior Policy Counsel, Access Now. Reacting to the allegations, a Google spokesperson said, "Our policies explicitly prohibit ads making demonstrably false claims that could undermine participation or trust in an election, which we enforce in several Indian languages."

Vedanta begins ops as mining resumes in Goa PRESS TRUST OF INDIA

Mining in Goa resumed after a gap of six years, with mencing operations on Thursday at Bicholim mineral block in the state.

Bicholim Mineral Block is the first auctioned mine to become operational since 2018 when the Supreme Court imposed a blanket ban on mining in the coastal state, the company said.

The mining in Goa came to a grinding halt in March 2018 after the Supreme Court quashed 88 mining leases.

"Heralding a new era of inclusive development, Vedanta Sesa Goa commenced mining operations at Bicholim Mineral Block-Block 1 in the state of Goa," the company said in a statement. Vedanta Limited had in 2022 emerged as a successful bidder for the mining block which was auctioned.

Vedanta was the highest bidder with 63.55 per cent revenue for Bicholim Mining Block. spread over 485 hectares.

Top four cement companies plan to add 42 mtpa in FY25

India's leading cement makers are on a capacity expansion spree. More than 42 million UltraTech Cement 21.6 expected to go onstream in the current finan-

Earlier this week, UltraTech Cement announced the commissioning of 5.4 million tonnes per annum (mtpa) capacity, taking its overall capacity to 151 mtpa. This is part of the 21.6 mtpa the company has guided to commission in the current financial year. UltraTech's closest competitor, ACC-Ambuja Cement, according to company disclosures, will add another 11.6 mtpa of capacity in FY25. Further, Shree Cement and Dalmia Cement, the other two of the top four cement makers, also have capacity commissioning lined up.

Shree Cement on Tuesday announced that it has commissioned fresh cement capacity of 3 mtpa, six months ahead of schedule. According to analyst estimates, the company is expected to add 6 mtpa of fresh capacity for the full financial year. Based on analyst estimates, the top four

companies will add 42.1 mt of cement capacity in FY25. This is about 9-10 per cent of total volumes estimated as sold in FY24. Email queries sent to the four companies remained unanswered at the time of writing this story. The rising capacity additions will strengthen market presence for the top four

NCDRC dismisses 2015 plea against sale of Maggi noodles

New Delhi, 4 April

The National Consumer Dispute Redressal Commission (NCDRC) has dismissed a 2015 complaint by the Department of Consumer Affairs (DoCA) against the sale of Maggi noodles, Nestle

ing on Thursday. The DoCA alleged that the company had indulged in unfair trade practices by manufacturing and selling hazardous and defective goods to the public.

India said in an exchange fil-

It further sought compensation of ₹284.55 crore and punitive damages to the tune of ₹355.41 crore from the company.

"The complaint filed by the Union of India, Department of Consumer Affairs in 2015... was dismissed by NCDRC in the favour of the company vide NCDRC's order dated April 2, 2024. The copy of the said order was

received by the company on April 3, 2024," Nestle said in the exchange filing. The Food Safety and Standards Authority of India (FSSAI) found excess levels of lead and monosodium glutamate (MSG) in Maggi noodles in 2015,

following which several states banned the product. The company had pulled out the product from the market and destroyed over 35,000 tonnes of Maggi noodles. However, the ban was lifted five months later.
